The German Longhaired Pointer Club (we or us) is committed to protecting your personal information and respecting your privacy.

This privacy notice sets out the basis on which any personal data we collect from or about you, or that you provide to us, will be processed by us.

For the purpose of the General Data Protection Regulation (Regulation [EU] 2016/679), the data controller is the German Longhaired Pointer Club, Pointers, Wistow Toll, Wistow, Huntingdon, PE28 2QH.

It is the responsibility of the Secretary to keep our Organisation and Committee informed and advised about their obligations to comply with data protection laws, to monitor compliance with those laws, to ensure that any necessary training is given and to conduct internal audits, and to be the first point of contact for supervisory authorities and for individuals whose personal data we are processing.

We process personal data about German Longhaired Pointer Club members and German Longhaired Pointer Club event entrants (all competitors including field trials, gundog working tests, pointing tests, show classes and seminars.)

What personal data do we process?

Name

Where do we obtain your personal data from?

Most of the above personal data is received direct from you as the data subject. However, information may be received from third parties. (e.g. joint membership, proposer/secunder name).

Why do we process your data and what is the lawful basis?

- Administration and transactional communications relating to your German Longhaired Pointer Club membership or associateship. **Contractual necessity.**

- Provision of services relating to your German Longhaired Pointer Club membership or associateship. **Contractual necessity.**
- Contacting you by e-mail to inform you of amendments to your German Longhaired Pointer Club membership or associateship. We will also make these changes available through our web site, so please check the web site regularly. **Legitimate Interests.**
- Contacting you by e-mail to inform you of seasonal events. **Legitimate interests.**
- Contacting you by post regarding items listed above where you do not have an e-mail facility. **Legitimate interests.**

How long do we hold personal data for?

Personal data will be retained for the duration of your membership or associateship.

Are you obliged to provide us with your personal data?

The provision of this personal data is a requirement necessary for the German Longhaired Pointer Club to administer its contracts with members and associates.

You are not obliged to provide the personal data in question. However, if you do not provide the personal data, we will be unable to perform or provide German Longhaired Pointer Club membership services to you.

Recipients of your personal data.

Membership data is not supplied to any person outside the German Longhaired Pointer Club.

Right to erasure.

You have the right to have your personal data deleted from our records at any time. Please contact the Secretary should this be the case.

2. Exhibitors/Competitors at German Longhaired Pointer Club events.

What personal data do we process?

- Name
- Address
- E-mail address
- Telephone number (s)
- Dog information

Where do we obtain your personal information?

Most of the above personal data is received direct from you as the data subject. However, where an event permits the employment of a different handler to the owner of the dog, it may be supplied by the person completing the entry form.

Why do we process your personal data and what is the lawful basis?

- Administration and transactional communications for exhibitors/competitors entering German Longhaired Pointer Club events. (Including information about the event). **Contractual necessity.**
- Provision of services relating to German Longhaired Pointer Club events. **Contractual necessity.**
- Publication of your name and dog information in the show, trial or test catalogue/programme. **Legitimate interests.**
- Publication of competitor results and awards to the Kennel Club, on the German Longhaired Pointer Club web site and with HPRFTINFO. **Legitimate interests.**
- Contacting you by post or e-mail regarding forthcoming German Longhaired Pointer Club events. **Legitimate interests.**

How long do we hold your personal data for?

- Data is held for up to a maximum of seven years from the date of the various events.

Are you obliged to provide us with your personal data?

The provision of this personal data is a requirement necessary for the German Longhaired Pointer Club to administer it exhibitors'/competitors' entries into German Longhaired Pointer Club events.

You are not obliged to provide the personal data in question. However, if you do not provide the personal data, we will be unable to perform any contract we have with you for entry into German Longhaired Pointer Club events.

Recipients of your personal data.

Your personal data is published in programmes and catalogues relative to the events you have entered. Copies of programmes and catalogues may be supplied to judges, hosts, other competitors and spectators at such events and to the Kennel Club.

Right to erasure.

You have the right to have your personal data deleted from our records at any time. Please contact the Secretary should this be the case.
